THIS ASSIGNMENT made this 14<sup>TH</sup> day of JUNE 2013

BETWEEN :

(1) EVOLUTION STUDIOS LIMITED being a company registered in England with No. 03754597 and having its registered office at 10 Great Marlborough Street, London W1F 7LP (" the Assignor ") and

(2) SONY COMPUTER ENTERTAINMENT EUROPE LIMITED being a company registered in England with No. 03277793 and having its registered office at 10 Great Marlborough Street, London W1F 7LP (" the Assignee ")

IT IS AGREED :

### 1. Definitions

In this Assignment the term " Trade Marks " shall mean :

1.1 the trade mark registered in the United Kingdom with No. 2351220 being DRIVE CLUB (word) in Classes 9 / 41 / 42 and

1.2 the trade mark registered in the European Union with No. 3870631 being DRIVE CLUB (word) in Classes 9 / 41 / 42 and

1.3 the trade mark registered in the United States with No. 3067514 being DRIVE CLUB (word) in Classes 9 / 41 / 42 and

1.4 the trade mark registered in the United States with No. 4315742 being DRIVE CLUB (word) in Classes 9 / 41 / 42

all being trade marks being registered in the name of the Assignor

### 2. Preliminary

The Assignor has agreed to assign the Trade Marks to the Assignee on the terms and conditions set out below

### 3. Assignment

In consideration of the sum of £ 1 (one pound) now paid by the Assignee to the Assignor (the sufficiency and receipt of which the Assignor acknowledges) the Assignor with full title guarantee assigns the Trade Marks and all goodwill attaching thereto to the Assignee absolutely with all the Assignor's rights and interest in respect of the Trade Marks including all statutory and common law rights and the right to sue for past infringements and to retain damages obtained as a result of such action

4. Registration of New Proprietor

The Assignor agrees with the Assignee at the direction and expense of the Assignee to execute any further document that the Assignee may reasonably require to enable the Assignee to be entered on record as the owner of any and all of the Trade Marks

5. Assignor's Warranties and Indemnity

The Assignor warrants that :

5.1 The Assignor is the owner of the Trade Marks and has full power to enter into this Assignment

5.2 The Assignor has not granted any assignments by way of security or charges or any licences to use the Trade Marks (save for any licences granted to the Assignee) on any date prior to the date of this Assignment

5.3 The Assignor has not knowingly caused or permitted anything which may either endanger the continuing registration of the Trade Marks or prevent the Assignee being entered on record as the owner of any and all of the Trade Marks

6. Proper Law and Jurisdiction

This Assignment shall be governed by the laws of England in every particular including formation and interpretation and in the event of any difference or dispute arising in relation to this Assignment both parties agree to submit to the jurisdiction of a court or competent tribunal in England
