NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns, and transfers unto Assignee the entire right, title and interest in and to the Marks and all accrued causes of action for damages for infringement thereof, the same to be held and enjoyed by Assignee for its own use and benefits, and for its legal representatives and assigns, to the full end of the term for which said Marks are granted (if applicable), as fully and as entirely as the same would have been held by Assignor had this assignment and sale not been made.

The undersigned hereby agrees and acknowledges that the Mark "The Issue is Quality of Life" was inadvertently omitted from the applicable portion of Schedule 1.1(a) of that certain Asset Purchase Agreement dated as of October 31, 2012 by and between Assignor and Assignee (the "APA") and that the APA shall be hereafter deemed amended to insert such Mark on such schedule and include the Mark as a "Trademark" for all purposes under the APA. Notwithstanding anything herein to the contrary, with the exception of the prior sentence, nothing herein shall expand or modify the rights or obligations of the parties as set forth in the APA.

This Trademark Assignment shall be binding upon and shall inure solely to the benefit of Assignor and Assignee and their respective successors and assigns.

This Trademark Assignment shall be governed by and construed in accordance with the internal laws of the Commonwealth of Massachusetts, without regard to any applicable principles of conflicts of law.

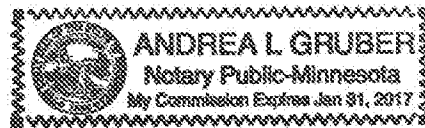
