The parties agree that upon written request by Assignee, Assignor shall sign any further documents or forms as may be reasonably required to have the Marks and Domain Names properly and duly registered with the competent Patent and Trademark Offices. However, this obligation shall terminate six (6) months after the Closing (as that term is defined in the Asset Purchase Agreement).

This Trademark Assignment shall be binding upon Assignor, Assignor's successors and assigns, and its affiliates.
