TERMINATION AND RELEASE OF TRADEMARK SECURITY INTERESTS

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY INTERESTS (this "Termination"), is dated as of October 23, 2006, and made by WELLS FARGO Foothill, INC., a California corporation, in its capacity as Agent ("Agent"), having an office at 2450 Colorado Avenue, Suite 3000 West, Santa Monica, California 90404, to MAGNETEK, INC., a Delaware corporation ("Grantor"), with its chief executive office at 10900 Wilshire Boulevard, Suite 850, Los Angeles, California 90024.

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of September 30, 2005, made by Grantor in favor of Agent (the "Security Agreement"), a security interest was granted by the Grantor to Agent in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on October 11, 2005, at Reel 003174 and Frame 0091; and

WHEREAS, Agent now desires to terminate and release its security interests to the Trademarks (as hereinafter defined) granted to Agent by the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Agent hereby states as follows:

1. Definitions. The term "Trademarks," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto.
2. Release of Security Interest. Agent hereby terminates, releases and discharges its security interest in the Trademarks and reassigns to the person or persons legally entitled thereto all right, title and interest of Agent in the Trademarks.
3. Continuation of Security Agreement. Except with respect to the Trademarks, the Security Agreement remains in full force and effect.


