SERVICE MARK ASSIGNMENT

WHEREAS, MOONLARK, INC. (hereinafter referred to as "ASSIGNOR"), a Maryland corporation, with a mailing address at 640 Owl Court, Arnold, Maryland 21012, is the owner of U.S. Registration No. 2973332 for the mark EQUINE EXTRAVAGANZA (hereinafter referred to as the "SERVICE MARK");

WHEREAS, COMMONWEALTH FAIRS & EVENTS, LLC (hereinafter referred to as "ASSIGNEE"), a Virginia limited liability company, with a mailing address at 13111 Dawn Boulevard, Doswell, Virginia 23047, is desirous of acquiring the entire right, title and interest in and to the SERVICE MARK and the goodwill of the business symbolized by the SERVICE MARK; and

WHEREAS, on April 23, 2013, COMMONWEALTH FAIRS & EVENTS, LLC entered into an Asset Purchase Agreement by which it acquired substantially all of ASSIGNOR's assets.

NOW, THEREFORE, in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR hereby sells, assigns and transfers to ASSIGNEE, the entire right, title and interest in and to the SERVICE MARK in all countries worldwide, all common law rights and all rights conferred by virtue of the federal service mark registration, together with the goodwill of the business symbolized by the SERVICE MARK, the right to claim priority rights deriving from the SERVICE MARK by virtue of international convention, treaty or otherwise, and the right to sue for and collect damages by reason of past infringements of the SERVICE MARK.

Effective as of April 23, 2013.


