ASSIGNMENT OF TRADEMARK

ASSIGNMENT OF TRADEMARK made as of the 7th day of March 2011 by Aldila Golf Corp., a Delaware corporation ("Assignor"), to Mary J. Hale, an individual ("Assignee").

For the sum of One Dollar (\$1.00), and other valuable consideration, the receipt of which is hereby acknowledged, Assignor does hereby assign, transfer and sell to Assignee, and Assignee hereby buys from Assignor, all right, title and interest in that certain mark "Pink Arrow Project" including the pending application before the US Patent and Trademark Office (# 77/862397), the scope of which is hereby incorporated by reference, and all of the goodwill associated therewith (the "Mark").

Assignor hereby agrees to execute such further instruments as the Assignee may reasonably request in order to more effectively assign, transfer, grant, convey, assure and confirm to Assignee and its successors and assigns, or to aid and assist in the collection of or reducing to possession by the Assignee of, such Mark.

In accordance therewith, Assignor desires to transfer and assign to Assignee, and Assignee desires to accept the transfer and assignment of, all of Assignor's worldwide right, title and interest in, to and under the Mark.

Assignee hereby accepts the transfer and assignment of, all of Assignor's right, title and interest in, to and under the Mark, together with the goodwill of the business associated therewith and which is symbolized thereby, all rights to sue for infringement of any Mark, whether arising prior to or subsequent to the date of this Assignment of Trademark, and any and all renewals and extensions thereof that may hereafter be secured under the laws now or hereafter in effect in the United States, the same to be held and enjoyed by the said Assignee, its successors and assigns from and after the date hereof as fully and entirely as the same would have been held and enjoyed by the said Assignor had this Assignment of Trademark not been made. Assignee hereby undertakes to hold harmless, indemnify, reimburse, and defend, Assignor from any loss, liability, claim, damage, expense (including costs of investigation and defense and reasonable attorneys' fees and expenses) arising from any use of the Mark by Assignee, or arising after the date of this Assignment of Trademark.

Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Assignment of Trademark shall be governed by and construed in accordance with the laws of the State of California without giving effect to the principles of conflicts of laws thereof.
