

On May 31, 2012, LobsterCo I, LLC, a Maine limited liability company with an address of 193 Park Street, Lewiston, ME 04240, participated in an acquisition agreement to which Bakeast Company also was a party. As a result of that acquisition agreement, LobsterCo I, LLC became the owner of the BAROWSKY'S trademark for bagels, bread, rolls, English muffins, and bakery goods, as well as the owner of Reg. No. 1640668 and all goodwill associated with that mark and that registration.

3. On November 21, 2012, LobsterCo I, LLC changed its name to Lepage Bakeries Park Street, LLC. Lepage Bakeries Park Street, LLC therefore became the owner of the

BAROWSKY'S trademark for bagels, bread, rolls, English muffins, and bakery goods, as well as the owner of Reg. No. 1640668 and all goodwill associated with that mark and that registration.
