## **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of July 16, 2013 ("Release"), is made by **SUNTRUST BANK**, a Georgia state banking corporation ("Lender"), in favor of **MALIBU BOATS, LLC**, a Delaware limited liability company ("Debtor").

**WHEREAS**, pursuant to that certain Security Agreement dated as of July 11, 2012 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Security Agreement") by and among the Debtor and Lender, and the Trademark and Patent Security Agreement dated as July 11, 2012 ("Trademark and Patent Security Agreement") by and among the Debtor and Lender, Debtor granted to the Lender a lien on and security interest in all of Debtor's right, title and interest in, to and under the Trademark and Patent Collateral; and

**WHEREAS**, the Trademark and Patent Security Agreement was recorded at the United States Patent and Trademark Office ("USPTO") on July 18, 2012 at Reel 028584 Frame 0293 and on July 18, 2012 at Reel 4824 Frame 0395.

**NOW THEREFORE**, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Lender and Debtor agree as follows:

**SECTION 1. Defined Terms.** Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement or Trademark and Patent Security Agreement.

**SECTION 2. Termination and Release.** Lender, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the right, title, and interest in, to, and under all the Trademark and Patent Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Debtor's expense.


**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of Tennessee.

**SECTION 4. Acknowledgement.** The release of security interest granted herein expressly does not include a release of the security interest granted pursuant to the Security and Pledge Agreement dated as July 16, 2013 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time) by and among the Obligors party thereto (as defined therein) and SunTrust Bank, in its capacity as Administrative Agent thereto (as defined therein).
