**RELEASE OF SECURITY INTEREST (TRADEMARKS)**

**THIS RELEASE OF SECURITY INTEREST** having an effective date of July 15th, 2013, by **VALUECLICK, INC.**, a Delaware corporation ("ValueClick"), is in favor of **WEB CLIENTS, LLC**, a Delaware limited liability company ("Web Clients").

**WHEREAS**, Value Click and Web Clients entered into that certain Security Agreement, dated February 1, 2010 (the "Security Agreement") pursuant to which Web Clients conveyed, pledged, assigned and transferred to ValueClick a security interest in the registered trademarks and service marks, applications for registration of trademarks and service marks, and licenses of registered trademarks and service marks listed in Schedule A hereto (the "IP Collateral").

**WHEREAS**, Web Clients executed on February 1, 2010 a Notice of Security Interest in Trademark, and recorded in the United States Patent and Trademark Office on March 4, 2010, at Reel 4159, Frame 0350 (Trademarks), under which Web Clients notified the United States Patent and Trademark Office of ValueClick's security interest in the IP Collateral;


**WHEREAS**, the Security Agreement was terminated on July 15, 2013 thereby terminating ValueClick's security interest in the IP Collateral; and

**WHEREAS**, ValueClick desires to assign, release, terminate, discharge, grant, convey, deliver and transfer its continuing security interest in the IP Collateral to Web Clients.

**NOW THEREFORE**, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, ValueClick hereby terminates, releases and discharges fully its lien on, and security interest in and to, all of the right, title and interest of Web Clients in, to and under the IP Collateral and reassigns and transfers any and all interest that ValueClick may have in the IP Collateral to Web Clients.
