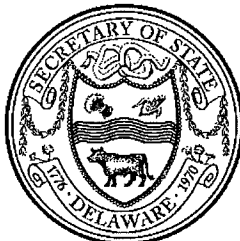




FIRST: Article I of the Corporation's Certificate of Incorporation is
