

TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of July 12, 2013, is made by JPMorgan Chase Bank, N.A., as Administrative Agent for the Lenders (together with its successors and assigns, the "Agent") (all terms used but not defined herein shall have the meaning assigned to such terms in the Trademark Security Agreement (as defined below)).

WHEREAS, Geavista Group, LLC, a Texas limited liability company formally known as Geavista Group, Inc. (the "Grantor") has granted a security interest in certain personal property to the Agent, including without limitation a security interest in certain trademarks and trademark applications ("Trademarks"), pursuant to that certain Trademark Security Agreement dated as of May 21, 2012 (the "Trademark Security Agreement");

WHEREAS, the security interests granted to the Agent were recorded at the United States Patent and Trademark Office as follows: on July 2, 2012 at Reel 4813 and Frame 0306;

WHEREAS, the Agent has agreed to terminate and release its security interest in all of such Trademarks, including, without limitation, the Trademarks identified on Schedule A attached hereto.

2. all goodwill of the business connected with the use of, and symbolized by, each Trademark; and
3. all products and proceeds of the foregoing, including, without limitation, any claim by Grantors against third parties for past, present or future (i) infringement or dilution of any Trademark or (ii) injury to the goodwill associated with any Trademark.
