

Pursuant to Section 264 of the Delaware General Corporation Law (“DGCL”), LTF Acquisition Corp., a Delaware corporation (the “Company”) hereby certifies the following information relating to the merger of ChronoTrack Systems, LLC, an Indiana limited liability company (the “Subsidiary”) with and into the Company, with the company surviving the merger (the “Merger”):

FIRST: The names and jurisdiction of formation of each of the constituent entities in the merger are as follows (the “Constituent Entities”):

FIFTH: As of the effective time of the Merger, the Certificate of Incorporation of the Company, as in effect immediately prior to the Merger, shall be the Certificate of Incorporation of the Surviving Corporation until thereafter changed or amended as provided therein or by applicable law.

SIXTH: The executed Merger Agreement is on file at the office of the Surviving Corporation located at 2902 Corporate Place, Chanhassen, MN 55317.


