WHEREAS Assignee further acknowledges that Assignee shall be solely responsible for all fees, costs, and expenses associated with the assignment of the Mark from Assignor to Assignee;

NOW, THEREFORE, for good and valuable consideration, the adequacy and receipt of which is hereby acknowledged, Assignor does hereby assign unto Assignee all right, title and interest in and to the Mark for the United States and throughout the world together with any common law rights and the goodwill of the business in connection with which the Mark is used and which is symbolized by the Mark, along with the right to recover for damages and profits for past infringements thereof, if any.
