Trademark Transfer Agreement

This Agreement is made by and between the following parties and shall become effective as of December 1, 2010.

China Connection Global Healthcare (hereinafter "Assignor"), a Maryland corporation, located at:

Phoenix, MD 21131

And

Soter Healthcare Inc. (hereinafter "Assignee"), a Minnesota corporation, located at:

11660 Theatre Dr N, Suite 280
Champlin, Minnesota 55316

1. SUMMARY

- 1.1. The Assignor is the owner of the Trademark along with the Trade Dress associated with the Trademark (hereinafter "the Trademark and Trade Dress") described in Exhibit A and the goodwill of the business relating to the healthcare and medical tourism services upon which the Trademark and Trade Dress are used and for which they are registered (hereinafter "the Goodwill").
- 1.2. The Assignor wishes to assign, transfer, convey and deliver to the Assignee all of its right, title and interest in and to the Trademark and Trade Dress along with the Goodwill.
- 1.3. In consideration for the mutual promises, covenants and agreements below, the parties agree as follows:

2. ASSIGNMENT

- 2.1. The Assignor hereby assigns, transfers, conveys and delivers to the Assignee all of its right, title and interest in and to the Trademark and Trade Dress along with (a) the Goodwill, (b) all income and royalties that become due or payable to the Assignor with respect to the Trademark and the Trade Dress, including payments for past, present or future infringements or misappropriations of the Trademark and Trade Dress and (c) all rights to sue for past, present or future infringements or misappropriations of the Trademark and Trade Dress.

- 2.2. No interest, share, assignment or other right to the Trademark has been transferred, assigned, or granted to any other party
- 2.3. The Assignor further assigns, conveys, transfers, delivers and contributes to the Assignee all rights in the Trade Dress, labels, and designs associated with the Trademark.
- 2.4. The Assignor further covenants that it will execute all documents, papers, forms and authorizations and take any and all other actions that may be necessary for securing, completing or vesting in the Assignee the full right, title and interest in the Trademark and Trade Dress.

3. ENTIRE AGREEMENT

This Agreement contains the entire agreement of the parties and there are no other promises or conditions in any other agreement whether oral or written. This Agreement supersedes any prior written or oral agreements between the parties.

4. AMENDMENT

This Agreement may only be modified or amended in writing and with execution by both parties.

5. SEVERABILITY

If any provision of this Agreement shall be held to be invalid or unenforceable for any reason, the remaining provisions shall continue to be valid and enforceable. If a court finds that any provision of this Agreement is invalid or unenforceable, but that by limiting such provision it would become valid and enforceable, then such provision shall be deemed to be written, construed, and enforced as so limited.

6. EFFECT ON HEIRS AND SUCCESSORS

This Agreement and each of its provisions shall be binding on and inure to the benefit of the respective heirs, devisees, legatees, executors, administrators, trustees, successors and assignees of the parties to this Agreement.

7. WAIVER OF CONTRACTUAL RIGHT

The failure of either party to enforce any provision of this Agreement shall not be construed as a waiver or limitation of that party's right to subsequently enforce and compel strict compliance with every provision of this Agreement.


8. APPLICABLE LAW

This Agreement shall be governed by the laws of the State of Minnesota, and any dispute related to this agreement shall be adjudicated by courts within the State of Minnesota.


