NUNC PRO TUNC TRADEMARK ASSIGNMENT

Assignor and Assignee agree to execute such further documents as may be reasonably necessary and appropriate to effect recorded transfer of title to such trademark and domain names.

4. TO BE HELD AND ENJOYED BY Assignee, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor had this sale and assignment not been made.
