**RELEASE AND TERMINATION  
OF  
TRADEMARK SECURITY AGREEMENT**

KNOW ALL MEN BY THESE PRESENTS, that a certain Trademark Security Agreement, dated as of June 6, 2012 (the "Trademark Security Agreement") was executed by Universal Services of America, Inc., a California corporation ("USA Inc."), Universal Building Maintenance, LLC, a California limited liability company ("UBM"), Universal Protection Security Systems, LP, a California limited partnership ("UPSS"), and Universal Protection Service, LP, a California limited partnership ("UPS", and, together with USA Inc., UBM and UPSS, the "Grantors"), covering the Trademarks and Trademark Licenses more fully described on Schedule 1 annexed hereto and made a part hereof in favor of JPMorgan Chase Bank, N.A. (the "Secured Party"), and recorded with the United States Patent and Trademark Office. Capitalized terms used herein and not otherwise defined have the meanings ascribed to them in the Trademark Security Agreement.

Grantors have requested and the Secured Party has agreed to release the Trademarks and Trademark Licenses and discharge the Trademark Security Agreement.

The Secured Party hereby releases its all right, title and interest in the Trademarks and Trademark Licenses which were pledged, mortgaged and set over or otherwise made subject to a lien to the Secured Party by Grantors pursuant to the Trademark Security Agreement and terminates the Trademark Security Agreement.

This agreement shall be governed by and construed and enforced in accordance with the internal laws (as opposed to conflicts of law provisions) of the State of California.
