RELEASE OF GRANT OF TRADEMARK SECURITY INTEREST

This Release of Grant of Trademark Security Interest ("**Release**") is made by Bank of America, N.A., Successor by Merger to Fleet National Bank, in favor of Casa Ole' East, Ltd. and Monterey's Acquisition Corporation, to correct the Release dated March 24, 2010, recorded with the U.S. Patent and Trademark Office ("**USPTO**") on March 29, 2010 at Reel 4175 Frame 0782;

WHEREAS, pursuant to a Patent and Trademark Security Agreement dated January 7, 2004, between Casa Ole' East, Ltd., as Borrower (hereinafter "**Borrower**"), and Fleet National Bank (now known as Bank of America, N.A., successor by merger), as Grantor (hereinafter "**Secured Party**"), and all amendments and modifications thereto (collectively, the "**IP Security Agreement**") and an Amended and Restated Security Agreement dated January 7, 2004 between Borrower and Secured Party and all amendments and modifications thereto (collectively, the "**Security Agreement**"), Borrower granted, assigned, transferred and conveyed to Secured Party, security interests in certain property of the Borrower, including but not limited to all of its right, title and interest in and to a certain trademark identified in the "**Schedule A**" attached hereto;

WHEREAS, the IP Security Agreement was recorded with the USPTO on January 15, 2004, at Reel 2897, Frame 0294, and again on May 5, 2004 at Reel 2964, Frame 0282;

WHEREAS, on January 30, 2004, Borrower assigned all of its right, title and interest in and to the trademark identified in the Schedule A attached hereto, together with the registration therefor, and the goodwill of Borrower's business symbolized by the trademark and associated therewith, to Monterey's Acquisition Corporation. The assignment was recorded with the USPTO on March 1, 2004, at Reel 2924, Frame 0347;


WHEREAS, Secured Party acknowledges full payment, performance and satisfaction of all of the obligations secured by the Security Agreement and IP Security Agreement, and desires to release all of Secured Party's right, title and interest in the trademark identified in the attached Schedule A, all registrations therefor, together with the goodwill of the business symbolized by the trademark and associated therewith; and

NOW THEREFORE, the Secured Party, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, fully and finally releases and relinquishes all right, title and interest granted to Secured Party by Borrower pursuant to the Security Agreement and IP Security Agreement, including but not limited to, all of Secured Party's right, title and interest in the trademark identified in the attached Schedule A, all registrations therefor, together with the goodwill of the business symbolized by the trademark and associated therewith.



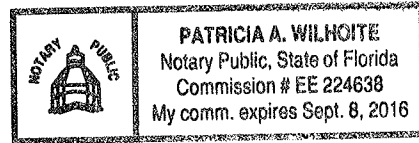
