GRANT OF SECURITY INTEREST (TRADEMARKS)

The undersigned, WEAVER LEATHER, LLC, a Delaware limited liability company (the "Grantor"), is obligated to KEYBANK NATIONAL ASSOCIATION, as Administrative Agent (in such capacity, the "Secured Party"), under the Credit Agreement, dated as of October 27, 2008 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and among the Grantor and the Secured Party, and pursuant to which the Grantor has entered into the Security Agreement, dated as of October 27, 2008 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), by and between the Grantor, the affiliates of Grantor from time to time party thereto and the Secured Party.

Pursuant to the Security Agreement, the Grantor has granted to the Secured Party a security interest in and to all of the present and future right, title and interest of the Grantor in and to the trademarks listed on Schedule 1, which trademarks are registered in the United States Patent and Trademark Office (the "Trademarks"), together with the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof (the "Collateral"), to secure the prompt payment, performance and observance of the Obligations (as defined in the Security Agreement).


