**RELEASE OF TRADEMARK SECURITY INTEREST**

WHEREAS, Longview Fibre Paper and Packaging, Inc., a Washington corporation ("Grantor") and Wells Fargo Bank, National Association acting in its capacity as Collateral Agent for the Secured Parties party to that certain Security Agreement ("Grantee"), entered into a Trademark Security Agreement dated May 24, 2011 ("Security Agreement");

WHEREAS, pursuant to that Security Agreement, Grantor granted to Grantee a security interest in substantially all of the assets of Grantor, including all right, title and interest of Grantor in, to and under all then owned and thereafter acquired Trademarks, together with the goodwill of the business symbolized by Grantor's Trademarks, and all products and proceeds thereof (Trademark Property);

WHEREAS, the Grantee's interest in Grantor's Trademark Property was recorded with the United States Patent and Trademark Office at reel/frame no. 004547/0929 and as identified on attached Schedule A;

WHEREAS, Grantee desires now to (i) release its security interest in Grantor's Trademark Property; (ii) waive all of its right, title and interest in and to Grantor's Trademark Property and restore all such right, title and interest in and to Grantor's Trademark Property to Grantor; and (iii) dissolve any and all liens and encumbrances respecting Grantor's Trademark Property.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Grantee does hereby release its security interest in Grantor's Trademark Property, and discharges, quit claims and relinquishes to Grantor, any and all right, title and interest it has in and to Grantor's Trademark Property referenced on Exhibit A;
