**RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE, dated as of July 18, 2013, is made by BARCLAYS BANK PLC, as Administrative Agent (the "Administrative Agent") under that certain Credit Agreement, dated as of February 3, 2012, between Post Holdings, Inc. and Administrative Agent (as amended, restated, supplemented, replaced or otherwise modified from time to time, the "Credit Agreement").

WITNESSETH

WHEREAS, pursuant to the Credit Agreement, Post Foods, LLC ("Post Foods") executed that certain Intellectual Property Security Agreement dated February 3, 2012 (the "Intellectual Property Security Agreement") and recorded with the U.S. Patent and Trademark Office on February 3, 2012 at Reel/Frame Nos. 27650/0204 and 4709/0854 and with the U.S. Copyright Office on February 7, 2012 at V3612 D941, pursuant to which the Post Foods granted to the Administrative Agent a security interest in and to all of its right, title and interest in and to the Intellectual Property Collateral (as defined in the Intellectual Property Security Agreement).

WHEREAS, pursuant to the Credit Agreement and that certain Assumption Agreement dated May 28, 2013, Attune Foods, LLC ("Attune Foods") executed that certain After-Acquired Intellectual Property Security Agreement (First Supplemental Filing) dated May 28, 2013 (the "First Supplemental Filing") and recorded with the U.S. Patent and Trademark Office on June 20, 2013 at Reel/Frame Nos. 30663/0635 and 5052/0308, pursuant to which Attune Foods granted to the Administrative Agent a security interest in and to all of its right, title and interest in and to the Intellectual Property Collateral (as defined in the First Supplemental Filing).

WHEREAS, pursuant to the Credit Agreement, Post Foods executed that certain After-Acquired Intellectual Property Security Agreement (Second Supplemental Filing) dated June 28, 2013 (the "Second Supplemental Filing") and recorded with the U.S. Patent and Trademark Office on July 3, 2013 at Reel/Frame No. 5063/0457, pursuant to which Post Foods granted to the Administrative Agent a security interest in and to all of such its right, title and interest in and to the Intellectual Property Collateral (as defined in the Second Supplemental Filing).

WHEREAS, Post Foods and Attune Foods has requested that the Administrative Agent release its security interest on all of its right, title and interest in and to its Intellectual Property Collateral.

NOW, THEREFORE, the Administrative Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse its security interest on all of its right, title and interest in and to the Intellectual Property Collateral, including the patents, patent applications, trademark registrations, trademark applications, and copyright registrations set forth in Schedule I, attached hereto and incorporated herein by reference, and agrees that all the security interest in the Intellectual Property Collateral are hereby discharged, terminated and released and hereby transfers and assigns to Post Foods and Attune Foods any and all right, title and interest that the Administrative Agent may have obtained in, to and under the Intellectual Property Collateral under the Intellectual Property Security Agreement, the First Supplemental Filing, and the Second Supplemental Filing.

The Administrative Agent agrees to provide Post Foods and Attune Foods with any information and additional authorization reasonably necessary to effect the release of the Administrative Agent's security interest in the Intellectual Property Collateral.

IN WITNESS WHEREOF, the Administrative Agent has caused this Release to be duly executed and delivered by its duly authorized officer as of the date first written above.
