## RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST ("Release") is granted and conveyed as of this 24<sup>th</sup> day of July 2013, by Wells Fargo Bank, National Association, as Collateral Agent (the "Agent") in favor of First Data Corporation (the "Obligor") and its successors in interest.

### WITNESSETH:

WHEREAS, pursuant to that Indenture dated as of December 17, 2010 among the Obligor, the Guarantors named on schedule I thereto and Wells Fargo Bank, National Association, as Trustee (the "Indenture"), Obligor granted a security interest (the "Security Interest") in certain of its tangible and intangible personal property, including trademarks;

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of December 17, 2010, among the Agent and Obligor (the "Trademark Security Agreement"), Obligor reaffirmed its intent to grant the Security Interest to the Agent specifically in certain trademarks, including the Released Trademarks (as hereinafter defined);

WHEREAS, Obligor has requested that Agent: (a) terminate and release the entirety of the Security Interest of Agent in the Released Trademarks; and (b) execute and deliver evidence of such termination and release for filing in the U.S. Patent and Trademark Office; and

WHEREAS, the parties now seek to make a record of Agent's termination and release of the entirety of their Security Interest in the Released Trademarks.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent in reliance on the certificate from the Obligor dated as of the date hereof, and without independent investigation, recourse or warranty of any kind, hereby releases, discharges, and relinquishes the Security Interest in the Released Trademarks, and any right, title or interest of the Agent in such Released Trademarks shall hereby cease and become void. Agent specifically acknowledges that all liens and security interests in the Released Trademarks is no longer in force.

The term "Released Trademarks," as used herein, shall mean any right, title and interest of every kind and nature in the trademarks listed on Schedule A hereto.

FURTHERMORE, the Obligor and the Agent acknowledge that the above release applies only to the Released Trademarks and shall have no effect on security interests to other property under the Indenture.
