WORLDWIDE TRADEMARK ASSIGNMENT

This Worldwide Trademark Assignment (the "*Trademark Assignment*") is entered into and is effective as of June 28, 2013 (the "*Effective Date*"), by and between Kidde-Fenwal, Inc., a Delaware corporation having a place of business at 400 Main Street, Ashland, MA 10721, Eau et Feu, a corporation of France having a place of business at Rue Aloys Senefelder, Reims 51100, France, Kidde Products Limited, a corporation of the United Kingdom having a place of business at Mathisen Way, Colnbrook, Slough, Berkshire SL3 0HB, United Kingdom, Kidde IP Holdings Limited, a corporation of the United Kingdom having a place of business at Mathisen Way, Colnbrook, Slough, Berkshire SL3 0HB, United Kingdom, Kidde Canada, Inc., a Canadian corporation having a place of business at 340 Four Valley Drive, Vaughan, ON, L4K 5Z1, and Canada, Chubb Fire Limited, a corporation of the United Kingdom having a place of business at Chubb House, Staines Road West, Sunbury on Thames, Middlesex, TW16 7AR, United Kingdom, (each an "*Assignor*" and collectively the "*Assignors*"), and Eurostar US Tradeco Inc., a Delaware corporation having a place of business at 180 Sheree Blvd. Suite 3900, Exton, PA 19341-0695 USA (the "*Assignee*").

The Assignors hereby transfer and assign to Assignee, effective as of the Effective Date, all of their respective worldwide right, title, and interest in and to the trademarks, trade names, service marks, applications and registrations described in Exhibit A, which is attached hereto and is incorporated by reference herein, and the goodwill of the business associated therewith (collectively, the "*Marks*").

For good and valuable consideration by Assignee, the receipt and sufficiency of which are hereby acknowledged, the Assignors do hereby assign unto the Assignee, as of the Effective Date, all of its right, title, and interest in and to the Marks, free and clear of all liens and encumbrances, together with all of the goodwill of the business associated with and symbolized by such Marks, the applications and registrations therefor, and any rights of the Assignors to sue any third parties for any past infringement of or to the Marks, for the use and behalf of Assignee and its successors, assigns or other legal representative and to prosecute such applications and registrations in the United States Patent and Trademark Office or in the trademark offices of any foreign jurisdiction. To the extent that any of the Marks are considered "intent to use" applications filed in the US Trademark Office, such Marks are being assigned with all or substantially all of the Assignor's business relating to the respective Mark.

After the Effective Date, at the request of the Assignee, at Assignors' expense, with regard to internal cost and Assignee's expense for out of pocket costs, and without additional consideration to the Assignors, the Assignors will execute and deliver to the Assignee, from time to time such further instruments of conveyance, transfer, and assignment and other documents, and will take such other actions, as the Assignee may reasonably require to convey and deliver more effectively to the Assignee the Marks, to perfect the Assignee's title thereto, and otherwise to accomplish the orderly transfer to the Assignee of the Marks and to give full effect to this Trademark Assignment. As soon as reasonably practicable after the Effective Date, Assignors shall execute all documents and make all necessary filings (the "Filings") required to update the relevant trademark office records around the world to reflect the current ownership status of the

Trademarks, such that upon completion of the Filings and acknowledgement by the respective trademark offices around the world, the ownership information listed in each respective trademark office around the world will match the ownership information provided by Sellers and listed in Exhibit A. Assignors further agree to provide monthly updates regarding the status for the Filings in each jurisdiction and provide written confirmation of the acceptance of the Filings and updated ownership details promptly upon receipt from each respective trademark office.

This Trademark Assignment is binding on the Assignors and their respective successors and assigns, and inures to the benefit of the Assignee and its successors and assigns.

This Trademark Assignment shall be governed by and construed in accordance with the internal laws of the Commonwealth of Pennsylvania without giving effect to any choice or conflict of law provision or rule (whether of the Commonwealth of Pennsylvania or any other jurisdiction).


Any legal suit, action or proceeding arising out of or based upon this Trademark Assignment may be instituted in the federal courts of the United States of America of the Eastern District of Pennsylvania located in the city of Philadelphia, Pennsylvania, and each party irrevocably submits to the exclusive jurisdiction of such courts in any such suit, action or proceeding.




