THIS ASSIGNMENT is made this 30th day of April 2013

BETWEEN

Hobby Products International, Inc. a US Corporation (State of Incorporation California), of 70 Icon Street, Foothills Ranch, California 92610-3000, USA (hereinafter called "the Assignor") of the one part,

AND

Hobby Products International Europe Limited a British Company (Company Registration No.3526977), of Unit 306 Fort Dunlop, Fort Parkway, Birmingham, West Midlands, B24 9FD (hereinafter called the Assignee") of the other part.

WHEREAS

- A. The Assignor is the proprietor of US trade mark registrations, particulars of which are set forth in the schedule hereto (hereinafter called "the Trade Marks").
- B. The Assignor and the Assignee are part of the Hobby Products International (HPI) group of companies (hereinafter called "the HPI Group").
- C. As a result of reviewing the HPI Group trade mark portfolio the parties have agreed that the Trade Marks and any and all other rights, title and interests that are held by the Assignor in and to the Trade Marks should be transferred by the Assignor to the Assignee.

NOW THIS ASSIGNMENT WITNESSETH as follows:

In consideration of the sum of US\$1.00 (one US Dollar) now paid by the Assignee to the Assignor (receipt of which is hereby acknowledged), the Assignor as the proprietor of the Trade Marks hereby:

- 1. Assigns with full title guarantee to the Assignee ALL the property, right, title and interest in and to the Trade Marks including all rights of action, power and benefit belonging or

accrued arising therefrom and the right to take proceedings to recover damages and claim all other relief in respect of any acts of infringement thereof or any unfair competition at common law whether such acts shall have been committed before or after the date of this Assignment TOGETHER with the goodwill of the business relating to the goods and services in respect of which the Trade Marks are registered.

2. The Assignor warrants in favour of the Assignee that at the date hereof the Trade Marks subsist and that nothing has been done nor has any event occurred whereby the Trade Marks may be declared void or invalid.
3. The Assignor covenants that he will execute all documents, paper, forms and authorisations and depose to or swear all declarations or oaths which may be necessary for securing, completing or absolutely vesting full right, title and interest to the Trade Marks in favour of the Assignee or of conferring on them all rights of action to any unfair competition by third parties at the date hereof.
4. The Assignor further covenants that the Assignee shall have and enjoy quiet possession of the Trade Marks uninterrupted or disturbed by the Assignor or any person claiming under or in trust for them.
5. This Assignment shall be governed by and construed in accordance with the laws of England and Wales and both parties agree to submit to the exclusive jurisdiction of the Courts of England and Wales over any claim or matter arising or in connection with this Assignment.
