ASSIGNMENT OF SERVICE MARKS

THIS ASSIGNMENT, dated July 26, 2013, is from Corizon, Inc. a corporation organized under the laws of the State of Missouri, with a business address of 105 Westpark Drive, Suite 200, Brentwood, Tennessee 37027 ("Assignor"), to Corizon Health, Inc., a corporation organized under the laws of the State of Delaware, with a business address of 105 Westpark Drive, Suite 200, Brentwood, Tennessee 37027 ("Assignee"). The Assignor and Assignee shall hereinafter be identified collectively as the "Parties."

WITNESSETH:

WHEREAS, Assignor is the sole owner of the exclusive right, title and interest in and to the service mark CORIZON, as well as the logo referred to as CORIZON & Design denoted in Exhibit A attached hereto (all collectively referred to as the "Mark" for purposes of the assignment herein), including all common law rights therein, as well as the application pending with the United States Patent & Trademark Office assigned the Serial Number of 85/345,270 (the "Application"), such Application based upon Assignor's actual use of the Mark;

WHEREAS, Assignor states that it has continued to use said Mark up to the date of the Assignment herein;

WHEREAS, Assignee is interested in acquiring the entire and exclusive right, title and interest in and to the Mark, and Application together with the goodwill of the business connected with the use of and symbolized by the Mark;

WHEREAS, Assignor desires to assign to Assignee, and Assignee desires to receive from Assignor, the entire and exclusive right, title and interest in and to the Mark and Application, together with the goodwill of the business connected with the use of and symbolized by the Mark;

NOW, THEREFORE, in consideration of one dollar (U.S. \$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns to Assignee and its successors, assigns and nominees without any restrictions, reservations, or limitations:

1. The entire and exclusive right, title and interest in and to the Mark and Application, together with the goodwill of the business connected with the use of and symbolized by the Mark, including the right to register the Mark in Assignee's name throughout the world; and

2. The sole right to enforce rights in said Mark and Application, with the right to sue for and recover for Assignee's own use accrued profits or damages for any and all causes of action, claims, and demands and other rights for infringements thereof, including, but not limited to past infringements with respect to which Assignor waives any right to receive any portion thereof.

Assignor covenants that Assignor has the full right to enter into this Assignment and further agrees without further consideration to cause to be performed such other lawful acts and to be executed such further assignments and other lawful documents as Assignee may from time to time reasonably request to effect fully this Assignment and to permit Assignee to be duly recorded as the legal and record owner of each of the rights hereby conveyed.
