**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Termination") dated as of July 26, 2013, from Bank of America, N.A., as Administrative Agent (the "Agent") for the holders of the Secured Obligations, to Options & Choices, Inc., a Wyoming corporation (the "Grantor").

WITNESSETH:

WHEREAS, pursuant to the Security and Pledge Agreement, dated as of June 11, 2012, made by the obligors party thereto, including the Grantor, in favor of the Agent (the "Collateral Agreement"), and that certain Grant of Security Interest in Trademarks, dated as of June 11, 2012, made by Grantor in favor of the Agent (the "IP Security Agreement"), Grantor granted a security interest (the "Security Interest") to the Agent for the benefit of the holders of the Secured Obligations in certain collateral, including the Trademarks and Trademark Licenses owned or acquired by Grantor (including, without limitation, those items listed on Schedule A hereto) (collectively, the "Trademark Collateral"); and


WHEREAS, the IP Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on June 12, 2012, at Reel 4799 and Frame 0762.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, the Agent hereby states as follows:

1. Definitions. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Collateral Agreement or IP Security Agreement.
2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral (including, without limitation, those items listed on Schedule A hereto), and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void.
3. Further Assurances. At Grantor's expense, the Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
