Pursuant to Section 18-209 of the Delaware Limited Liability Company Act (the "*DLLCA*"), this Certificate of Merger is being executed and filed for the purpose of merging Yurman Studio, Inc., a New York corporation, with and into David Yurman IP LLC, a Delaware limited liability company. Yurman Studio, Inc., David Yurman IP LLC and Yurman Family Holdings Inc., a Delaware corporation and the indirect parent of Yurman Enterprises, do hereby certify:

**FIRST:** That the name and state of organization of each of the constituent entities to the merger (the "*Merger*") are as follows:

**SIXTH:** That a copy of the Merger Agreement will be furnished by the surviving or resulting domestic limited liability company, on request and without cost to any member of

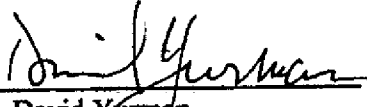
any domestic limited liability company or any person holding an interest in any other business entity which is to merge or consolidate.

**SEVENTH:** That this Certificate of Merger shall be effective upon its filing with the Secretary of State of the State of Delaware.

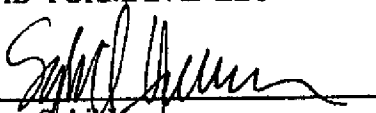

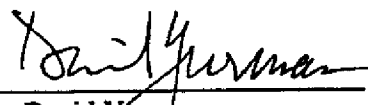
