AND, ASSIGNOR hereby authorizes and requests the U.S. Patent and Trademark Office, or any foreign equivalent thereof, to record ASSIGNEE as the owner of the MARKS as assignee of the entire right, title and interest in, to and under the same, for the sole use and enjoyment of ASSIGNEE, its successors, assigns or other legal representatives;

AND, ASSIGNOR hereby agrees further that it will, at ASSIGNEE's expense, when requested, execute, deliver and acknowledge such further instruments of conveyance and do and perform all such other acts and things as ASSIGNEE may reasonably require to more effectively accomplish the assignment, transfer and recordation thereof of the said MARKS.
