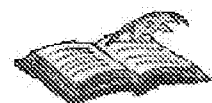


Declaration Pursuant to 28 USC §1746

I, Jeffrey M. Gitchel, state as follows:

1. I am Senior Counsel for Bayer Corporation and Attorney of Record for the captioned trademark registrations ("the Marks").
2. I am fully competent and authorized to make this Declaration on behalf of Bayer HealthCare Pharmaceuticals Inc.
3. I have knowledge of the relevant facts relating to the ownership of the Marks.
4. On January 15, 2013, a merger was recorded on Reel/Frame 4943/0406 transferring ownership of the Marks from Intendis, Inc. to Bayer HealthCare Pharmaceuticals Inc.
5. The owner of the Marks was Intendis GmbH and not Intendis, Inc., and therefore the application to record the above-referenced merger was in error.
6. Ownership of the Marks remained with Intendis GmbH and the merger of Intendis, Inc. into Bayer HealthCare Pharmaceuticals Inc. did not affect the ownership of the Marks.
