TRADEMARK ASSIGNMENT

1. Assignor confirms that it has sold, transferred, conveyed and assigned to Assignee, and Assignee accepted from Assignor, all right title, and interest in and to the Marks together with the goodwill associated with the Marks, including the trademark registrations therefor, as well as all common law rights thereto. Assignee has the sole right to sue and collect damages and/or profits for both past and present infringements of the Marks.
2. Assignee, at its own cost and expense, shall record a fully executed copy of this Confirmatory Assignment with the United States Patent and Trademark Office and any other agency, including foreign trademark offices, having jurisdiction over the ownership of the Marks.
