## ARTICLES OF MERGER

### DOMESTIC AND FOREIGN FOR-PROFIT CORPORATIONS

08 DEC 29 PM 2:00

The name of the merging (non-surviving) Washington Corporation is **Lifeline International, Inc.** ("Lifeline One").

2. The name of the surviving Wisconsin corporation is **Lifeline International, Inc.** ("Lifeline Two").
3. The Plan of Merger has been approved and adopted by each corporation party to the merger as required under Wisconsin Statutes Section 180.1103 and the Revised Code of Washington, Section 23B.11.030 and is attached hereto as Exhibit A.
4. The Articles of Incorporation of Lifeline Two, shall be the articles of incorporation for the surviving corporation.
5. The surviving corporation will provide a copy of the plan of merger, upon request and without cost to any shareholder of any corporation that was a party to the merger, or upon payment to the surviving corporation of an amount equal to the cost of producing the copy, to any other interested person.
6. The non-surviving Washington entity has a fee simple interest in the real property more accurately described below in the State of Wisconsin and a merger report will be filed with the Wisconsin Department of Revenue pursuant to Wisconsin Statute Section 73.14 regarding the same:

Unit 603 & 605 in StorageShopUSA-Post Road Condominium, a Condominium created by a "Declaration of Condominium" recorded on October 27, 2006, in the Office of the Register of Deeds for Dane County, Wisconsin as Document No. 424875, and by its Condominium Plat.

7. These articles of merger shall be effective on December 31, 2008.
