RELEASE OF MASTER SECURITY AGREEMENT

This RELEASE OF MASTER SECURITY AGREEMENT, granted by OMNICARE, INC., a Delaware corporation ("OMNICARE"), is effective July __, 2013.

W I T N E S S E T H :

WHEREAS, eHEALTH SOLUTIONS INC., a Delaware corporation ("eHEALTH") and OMNICARE entered into a Master Security Agreement, effective as of July 3, 2009 (the "Master Security Agreement"), pursuant to which eHEALTH granted to OMNICARE a security interest in all of the Collateral (as such term is defined in the Master Security Agreement);

WHEREAS, the Master Security Agreement was recorded with the United States Patent and Trademark Office on July 8, 2009 at Reel 4018, Frame 0820 with respect to the United States trademark registrations listed on SCHEDULE 6 TO PERFECTION CERTIFICATE, LIST OF PATENTS, TRADEMARKS, COPYRIGHTS AND SOFTWARE, attached to the Master Security Agreement;

WHEREAS, the Master Security Agreement was recorded with the United States Copyright Office on July 16, 2009 under Document Number V3579D623 with respect to the Software and Software Licenses listed on SCHEDULE 6 TO PERFECTION CERTIFICATE, LIST OF PATENTS, TRADEMARKS, COPYRIGHTS AND SOFTWARE attached to the Master Security Agreement;

WHEREAS, eHEALTH has requested that OMNICARE release its liens under the Master Security Agreement; and


WHEREAS, OMNICARE is willing to release such liens;

NOW, THEREFORE, OMNICARE hereby releases its entire right and interest in the Collateral, created by the Master Security Agreement, and said Master Security Agreement and all liens and security interests granted thereby to OMNICARE shall hereupon and hereby do cease and terminate.
