Confirmatory Trademark Assignment

Assignor agrees, at the request and the sole expense of Assignee, to take or cause to be taken all such other actions, including the execution of any and all other instruments in writing, further applications, papers, affidavits, powers of attorney, assignments and other documents, which may be reasonably required or necessary to more effectively secure to, and vest in, Assignee and its successors and assigns, the entire right, title and interest in and to the Trademarks and otherwise to effectuate fully the purposes, terms and conditions of this Confirmatory Assignment Agreement.
