Ladies and Gentlemen:

Please be advised that pursuant to the Revolving Credit and Security Agreement, dated as of July 31, 2013 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and among PPG Intermediate Holdco, Inc., a Delaware corporation ("Holdings"), and prior to the Closing Date Acquisition (as defined in the Credit Agreement), the "Borrower"), Professional Plumbing Group, Inc., a Delaware corporation ("PPG"), Wolverine Brass, Inc., a Delaware corporation ("Wolverine") and Plumbmaster, Inc., a Delaware corporation ("Plumbmaster" and, following the Closing Date Acquisition, together with PPG, Wolverine and each Person joined thereto as a borrower from time to time, collectively, the "Borrowers" and each individually, a "Borrower"), the financial institutions which are now or which hereafter become a party thereto (collectively, the "Lenders") and PNC Bank, National Association, as agent for the Lenders (in such capacity, the "Agent"), the undersigned (the "Grantor") has granted a continuing security interest in and continuing lien upon, the trademarks and trademark applications set forth on Schedule 1 attached hereto to the Agent for the ratable benefit of the Lenders. Capitalized terms not herein defined shall have the meaning ascribed to such terms in the Credit Agreement.

The undersigned Grantor and the Agent, on behalf of the Lenders, hereby acknowledge and agree that the security interest in the trademarks and trademark applications set forth on Schedule 1 attached hereto (i) shall be terminated and released in accordance with and pursuant to the Credit Agreement and (ii) is not to be construed as or deemed to be an assignment of any trademark or trademark application. Upon the termination of the security interest in the trademarks and trademark applications set forth on Schedule 1 attached hereto, pursuant to the terms of the Credit Agreement, the Agent (at the direction of the Required Lenders) shall execute all documents, make all filings and take all other actions necessary to evidence and record the release of the security interests in the trademarks and trademark applications set forth on Schedule 1 attached hereto granted herein.
