1. The name of the corporation is LUVATA BUFFALO, INC., a Delaware corporation (the "Corporation").
2. The Certificate of Incorporation of the Corporation was filed by the Department of State of the State of Delaware on June 22, 1990.
3. The Certificate of Incorporation of the Corporation is hereby amended to change the name of the Corporation from LUVATA BUFFALO, INC. to AURUBIS BUFFALO, INC.

To effect such amendment:

Paragraph "1." of the Certificate of Incorporation is hereby amended to read in its entirety as follows:
