TRADEMARK RELEASE

This Trademark Release is entered into as July 30, 2013, by JPMorgan Chase Bank, N.A., a national banking association (“Chase”).

Brickyard Trademarks, Inc., a Nevada corporation (the “Company”) entered with Chase into a Trademark Security Agreement dated as of December 31, 2008 granting Chase a security interest in the Trademarks as defined therein, including the marks set forth in Schedule 1 hereto (the “Trademark Agreement”).
