RELEASE OF TRADEMARK COLLATERAL ASSIGNMENT

WHEREAS, **LILLIE RUBIN FASHIONS, INC.**, a Delaware corporation (the "Assignor") granted a security interest to **WELLS FARGO BANK, NATIONAL ASSOCIATION** (as successor by merger to Wells Fargo Bank Minnesota, National Association, as successor by merger to Norwest Bank Minnesota South, National Association), (the "Bank"), in Assignor's Trademarks pursuant to that certain Trademark Collateral Assignment dated as of January 21, 1997 (the "Trademark Assignment");

Releases and reassigns any and all liens, security interests, right, title and interest of Bank pursuant to the Trademark Assignment in the Trademarks including those identified in Exhibit A and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, attached hereto, without recourse or representation or warranty, express or implied of any kind;

Bank agrees that, upon the request of the Assignor or any successor in interest or assignee thereof, and at the expense of the Assignor, Bank will execute any document, cause to be made any filing or take any other action deemed reasonably necessary or advisable by the Assignor, or any successor in interest or assignee thereof, to effectuate the release of interests contemplated herein.

Definitions: Unless otherwise defined herein, terms used in this Release of Trademark Collateral have the meanings provided in the Trademark Assignment.

IN WITNESS WHEREOF, the Bank, by the signature below of its duly authorized representative, agrees to be bound by the provisions of this Release of Trademark Collateral Assignment as of this 25th day of July, 2013.
