THIS RELEASE OF TRADEMARK COLLATERAL (this "Release") is made as of January 7, 2011, by WELLS FARGO BANK, NATIONAL ASSOCIATION, as administrative agent (in such capacity as the "Administrative Agent"), the secured party under the Security Agreement referred to below.

WITNESSETH:

WHEREAS, PreVisor Inc. (as successor by merger to ePredix, Inc. and Qwiz, Inc.) ("Grantor"), and certain other entities executed that certain Security Agreement (Intellectual Property), dated as of August 1, 2005 (the "Security Agreement"), pursuant to which Grantor granted a security interest to the Administrative Agent in certain trademarks and other intellectual property of Grantor; and


WHEREAS, two Grants of Security Interest – Trademarks executed in connection with said Security Agreement were recorded with the United States Patent and Trademark Office at Reel 003152, Frame 0809 on September 2, 2005 and at Reel 003152, Frame 0790 on September 2, 2005, respectively; and

WHEREAS, the Administrative Agent has agreed to release all its liens on the trademarks and trademark applications of Grantor identified on Exhibit A attached hereto and made a part hereof (the "Released Collateral"), and to reconvey any and all rights in the Released Collateral to Grantor.

NOW, THEREFORE, in consideration of the promises and other good and valuable consideration, receipt of which is hereby acknowledged, the Administrative Agent hereby releases all its rights in and to the Released Collateral, reconveys and reassigns to the Grantor all of the Administrative Agent's right, title and interest in and to the Released Collateral, all without warranty or representation of any kind.
