## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is made as of July 25, 2013 (“Effective Date”) by and between **Wells Fargo Capital Finance, LLC**, a Delaware limited liability company, with offices at One Boston Place, 18th Floor, Boston, Massachusetts 02108 (“Grantee”), in its capacity as agent for the Lender Group and the Bank Product Providers as defined in that certain Guaranty and Security Agreement by and between Grantor and Grantee dated October 13, 2011, and **Voxeo Corporation**, a Delaware Corporation, with offices at 2325 E. Camelback Road, Suite 700, Phoenix, AZ 85016 (“Grantor”).

**WHEREAS**, pursuant to the terms and conditions of that certain Trademark Security Agreement by and between Grantor and Grantee dated October 13, 2011 (the “Trademark Security Agreement”), Grantor granted to Grantee a continuing security interest in and to all of Grantor’s right, title and interest in and to all of the trademarks, and registrations of and applications to register the foregoing, and all of the trade names and assumed names owned by Grantor (collectively, the “Trademarks”), including, without limitation, the United States trademark registrations and applications set forth on Schedule A attached hereto, in each case, together with the goodwill associated therewith;

**WHEREAS**, Grantor and Grantee entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain Guaranty and Security Agreement by and between Grantor and Grantee dated October 13, 2011 (the “Security Agreement”);

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on October 14, 2011, at Reel 4641, Frame 0724; and

**WHEREAS**, Grantor has paid all of its outstanding indebtedness to Grantee.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Trademark Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademarks.


Grantee represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademarks; and (iii) it has not recorded or otherwise evidenced its security interest with respect to any trademark, or registration of an application to register any trademark, or any trade name or assumed name, other than those Trademarks set forth on Schedule A (attached hereto), in any jurisdiction throughout the world.

Grantee shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
