RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of July 31, 2013 (the "Effective Date") by **SILICON VALLEY BANK**, in its capacity as Administrative Agent (in such capacity, the "Assignee"), in favor of each of **BANDWIDTH CONSULTING, INC., EASYNEWS HOLDINGS, INC., HIGHWINDS MEDIA GROUP, INC., UNS HOLDINGS, INC. and HIGHWINDS NETWORK GROUP, INC.** (in its individual capacity and as successor by merger to Puregig Holdings, Inc.) (each a "Grantor" and collectively, the "Grantors").

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated as of February 22, 2010 (the "Original Trademark Security Agreement"), made by the Grantors (other than Bandwidth Consulting, Inc.) in favor of the Assignee, and that certain Joinder and First Amendment to Trademark Security Agreement, dated as of June 30, 2010 (the "Trademark Security Agreement Amendment"), and together with the Original Trademark Security Agreement, the "Trademark Security Agreement"), made by the Grantors in favor of the Assignee, the Grantors granted to the Assignee a continuing security interest in, to and under the Trademarks (as defined in the Trademark Security Agreement), including, without limitation, the trademarks set forth on Schedule 1 attached hereto;

WHEREAS, the Original Trademark Security Agreement was recorded with the United States Trademark and Trademark Office on March 9, 2010 at Reel/Frame 4164/0244, and the Trademark Security Agreement Amendment was recorded with the United States Patent and Trademark Office on August 11, 2010 at Reel/Frame 4259/0361; and

WHEREAS, the Obligations (as defined in the Guarantee and Collateral Agreement referred to in the Trademark Security Agreement) have been repaid in full and Assignee has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest and continuing lien on the Trademarks, including, without limitation, the trademarks set forth on Schedule 1 attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignee hereby unconditionally and expressly (a) terminates the Trademark Security Agreement, and (b) terminates, cancels and releases any and all security interests it has against the Trademarks, including, without limitation, the trademarks set forth on Schedule 1 attached hereto.

If and to the extent the Assignee has acquired any right, title or interest to any of the Trademarks, including, without limitation, the trademarks set forth on Schedule 1 attached hereto, it hereby assigns and transfers such rights, title or interest to the applicable Grantor.

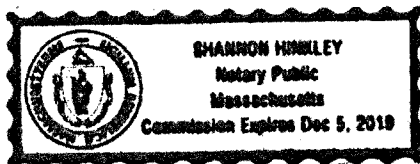
