NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of January 23, 2008 (the "Security Agreement"), by Key Brand Entertainment Inc., as Domestic Borrower ("KBE"), Toronto Theatre Ltd., as Canadian Borrower ("TTL"), the other Grantors signatory thereto (the "Other Grantors", and, together with KBE and TTL, the "Grantors"), and JP Morgan Chase Bank, N.A., as administrative agent and as Issuing Bank (in such capacity, the "Agent"), recorded in the United States Patent and Trademark Office at Reel 4434, Frame 0541, the Grantors assigned and granted to the Agent a security interest in the Grantors' right, title and interest in and to the trademark registrations and applications listed on Schedule A hereto (the "Trademarks") and the Trademark licenses listed on Schedule B, together with all products and proceeds of, and income from, any of the foregoing, including, without limitation, any claim by the Grantors against third parties for the past, present or future infringement or dilution of any Trademark or any Trademark licensed under any Trademark license, or for injury to the goodwill associated with any Trademark (the "Released Assets"); and

WHEREAS, the Agent wishes to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge of its security interest in the Released Assets;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent agrees as follows:

1. Release. The Agent hereby relinquishes, releases and discharges its security interest in the Released Assets.


2. Further Assurances. The Agent hereby agrees, at the Grantors' expense, to execute such instruments and to take such other actions as the Grantors or their legal representatives may reasonably request to terminate the Agent's security interest in the Released Assets.

3. Governing Law. This Notice of Release of Security Interest in Trademarks shall be governed by and construed and interpreted in accordance with the laws of the State of New York.

4. Definitions. Capitalized terms used herein and not defined shall have the respective meaning ascribed to such terms in the Security Agreement.



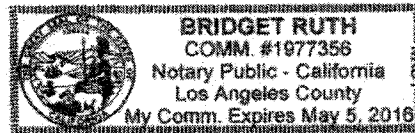
