## TRADEMARK ASSIGNMENT STATEMENT

This Statement, dated May 30, 2013, is being signed and submitted as a supporting document to effectuate the assignment of certain trademarks with the United States Patent and Trademark Office ("USPTO") between Mr. Bar-B-Q-, Inc., a New York corporation with a principal place of business located at 445 Winding Road, Old Bethpage, New York 11804 ("Assignor") and Ferrellgas Real Estate, Inc., a Delaware corporation with a principal place of business located at 7500 College Boulevard, Suite 1000, Overland Park, KS 66210 ("Assignee").

WHEREAS, pursuant to an Asset Purchase Agreement dated March 22, 2013 (the "Agreement"), Assignee acquired substantially all of Assignor's right, title and interest to Assignor's tangible and intangible property (including associated goodwill), including all registered and unregistered trademarks;

WHEREAS, the Agreement contains certain confidential information which Assignor and Assignee wish to keep as confidential and they do not wish to make the terms of the Agreement a matter of public record;


WHEREAS, in lieu of filing a copy of or an extract from the Agreement, Assignor and Assignee wish to file this Statement acknowledging and explaining how title to the trademarks passed from Assignor to Assignee.

1. Assignor and Assignee entered into the Agreement on March 22, 2013, wherein, substantially all of Assignor's right title and interest to its tangible and intangible property (with associated goodwill) was to be transferred to Assignee.
2. On March 22, 2013, Assignor and Assignee effectuated the transfer of Assignor's assets to Assignee.
3. Included in the acquired assets, among other things, were all of Assignor's registered trademarks, as well as, all of Assignor's trademark applications filed with the USPTO.
4. As such, as of March 22, 2013, Assignee acquired all of Assignor's right, title and interest in and to the registered trademarks and pending trademark applications.
5. This Statement is being submitted with the USPTO as a supporting document so that the trademark assignments may be properly filed with the USPTO and in lieu of submission of the entire Agreement.
