Pursuant to the provisions of the General and Business Corporation Law of Missouri, the undersigned Corporation certifies the following:

1. The present name of the Corporation is **San Val Incorporated** (Missouri charter number 00101009).

The name under which it was originally incorporated was **Sanval Corporation**.

2. An amendment to the Corporation's Articles of Incorporation was adopted by the shareholders on May 29, 2013.
3. Article I of the Corporation's Articles of Incorporation is hereby amended and restated to read as follows:

"ARTICLE ONE

The name of the corporation is: Turtleback Books, Inc."

4. Article Six of the Corporation's Articles of Incorporation is hereby amended and restated to read as follows:

"ARTICLE SIX

The number of directors shall be fixed or changed in the manner provided in the By-laws of the corporation."

5. Article Eight of the Corporation's Articles of Incorporation is hereby amended by adding the following item 12 below existing item 11:

"12) In general, to engage in and carry on any other lawful business and to have and exercise all the powers conferred by the laws of Missouri upon a corporation formed under the General and Business Corporation Law of Missouri and to do any or all of the things hereinbefore set forth to the same extent as a natural person might or could do."

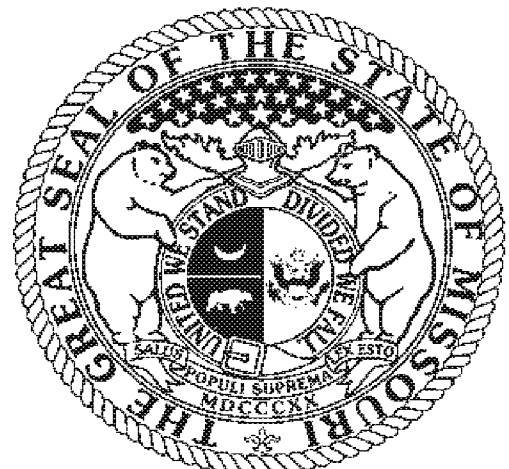
