**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY**

This Release, effective as of August 1, 2013, is granted by Wells Fargo Bank, National Association, a national banking association, to Accuride Corporation, a Delaware corporation and Imperial Group Holding Corp.-1, a Delaware corporation (each, a "Grantor" and collectively, the "Grantors"), each with their principal office at 7140 Office Circle, Evansville, IN 47715, as follows:

WITNESSETH

WHEREAS, the Grantors have heretofore granted to Wells Fargo Bank, National Association, a national banking association, in its capacity as agent for each member of the Lender Group (as defined therein) and the Bank Product Providers (as defined therein) (in such capacity, the "Agent"), a security interest in certain trademarks, trademark registrations and trademark applications and the goodwill associated therewith as set forth on Schedule A attached hereto (the "Intellectual Property"), pursuant to that certain Guaranty and Security Agreement dated as of July 11, 2013 by and among the Grantors, the other grantors listed therein and the Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Guaranty and Security Agreement"); and

WHEREAS, in connection with the consummation of the sale of certain assets of Imperial Group, L.P. and the Grantors to Imperial Group Manufacturing, Inc. ("Buyer"), the Agent wishes to release and restore all right, title and interest in and to the Intellectual Property to the Grantors and to dissolve any and all liens and encumbrances respecting the Intellectual Property.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby without recourse and without representation or warranty of any kind (either express or implied), releases, discharges, quit claims and relinquishes unto the Grantors any and all right, title and interest in and to the Intellectual Property granted to the Agent by the Grantors pursuant to the Guaranty and Security Agreement. The Agent hereby agrees that upon the reasonable request of either the Grantors or Buyer, the Agent will, at the expense of the Grantors, execute and deliver to the Grantors or Buyer such documents reasonably acceptable to the Agent as are needed to evidence the release of such right, title and interest in and to the Intellectual Property from the security interest granted by the Guaranty and Security Agreement.
