NUNC PRO TUNC ASSIGNMENT

Assignor hereby sells, assigns, transfers, and conveys to Assignee its entire right, title, and interest in and to the Mark, together with the goodwill of the business associated with and symbolized by the Mark, the same to be held and enjoyed by Assignee as fully and entirely as said interest could have been held and enjoyed by Assignor had this sale, assignment, transfer and conveyance not been made.

Assignor authorizes the Commissioner for Trademarks and other empowered officials of the United States Patent and Trademark Office to record this Assignment. Assignor further agrees to execute any documents reasonably necessary to effect this Assignment or to confirm Assignee's ownership of the Mark.

This Assignment shall be effective retroactively as of January 7, 2006.
