## **RELEASE AND TERMINATION OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE AND TERMINATION OF SECURITY INTERESTS IN TRADEMARKS** (this "Release") is made as of August 2, 2013 ("Effective Date") by CapitalSource Finance, LLC in its capacity as agent ("Agent") in favor of Devcon Security Holdings, Inc. (f/k/a Devcon Security Services Corp.), a Florida corporation, Devcon Security Services Corp. (f/k/a Security Equipment Company, Inc.), a Delaware corporation, and Mutual Central Alarm Services Inc., a New York corporation (individually and collectively, "Grantor"). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Security Agreement (as defined below).

**WHEREAS**, Grantor and the Agent entered into that certain Security Agreement by and among Grantor, the Agent and certain of the Loan Parties (as defined in the Second Amended and Restated Credit Agreement, dated as of July 6, 2011, by and among Agent, the Lenders and the Loan Parties) dated November 10, 2005, as amended (the "Security Agreement"), wherein Grantor granted to the Agent, as agent for the Lenders, a continuing security interest in all right, title and interest of Grantor in, to and under the Collateral (as defined in the Trademark Security Agreement defined below);

**WHEREAS**, pursuant to the Security Agreement, that certain Acknowledgment of Security Interest in Trademarks dated July 6, 2011 (the "Trademark Security Agreement") was entered into by Grantor to record the security interest with respect to the Collateral (as defined in the Trademark Security Agreement), including the Trademarks (as defined in the Security Agreement) set forth on Schedule A attached hereto, and was recorded with the United States Patent and Trademark Office on July 19, 2011 at Reel 04585/Frame 0944; and

WHEREAS, Grantor requests a specific release of the security interest granted and recorded against the Collateral.


**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby, on behalf of itself and the Lenders, (i) terminates the Trademark Security Agreement and releases and re-assigns to Grantor any and all liens, security interests, right, title and interest it may have in, to and under the Collateral, together with the goodwill of the business symbolized thereby; and (ii) authorizes and requests that the United States Patent and Trademark Office note and record the release hereby given and any other filings necessary to evidence the release and termination of the Agent's rights under the Security Agreement with respect to the Collateral.

This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
