TRADEMARK SECURITY INTEREST

WHEREAS, pursuant to a Security Agreement dated January 4, 2011 (the "**Senior Security Agreement**"), between Proxim Wireless Corporation, a Delaware corporation (the "**Debtor**"), and ProxAgent, Inc., a Delaware corporation (the "**Collateral Agent**"), for the Lenders, Debtor agreed to grant in favor of Collateral Agent a security interest in Marks of Debtor, whether then owner by or owing to Debtor, or thereafter acquired by or arising in favor of Debtor;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, subject to the terms and conditions of the Senior Security Agreement, Debtor hereby confirms its grant and does grant to Collateral Agent a lien and continuing security interest in and to, and a right of set-off against, the following:

- (i) all trademarks and trademark registration listed on Schedule A (the "New Marks"); and
- (ii) all renewals of trademark registrations listed on Schedule A.

Debtor further acknowledge that the rights and remedies of the Collateral Agent with respect to the security interest in the New Marks confirmed and granted hereby are more fully set forth in the Senior Security Agreement, the terms and provisions of which are fully applicable to the New Marks.
