## TRADEMARK ASSIGNMENT AND ASSUMPTION AGREEMENT

This TRADEMARK ASSIGNMENT AND ASSUMPTION AGREEMENT made as of this 19th day of December, 2012 (this "Assignment") between GOLDEN DOOR LICENSOR L.L.C., a Delaware limited liability company, and WIND INTERNATIONAL L.L.C., a Delaware limited liability company (collectively, "Assignor"), and GOLDEN DOOR PROPERTIES, LLC, a Delaware limited liability company ("Assignee").

**WHEREAS**, Assignor desires to assign to Assignee and Assignee wishes to acquire from Assignor, all of Assignor's rights, title and interest in and to the trademarks "Golden Door Spa" and related marks throughout the United States and the world, including but not limited to those set forth on Schedule 1 attached hereto (the "Marks");

**NOW THEREFORE**, in consideration of the foregoing recitals and the promises and the mutual covenants herein contained, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. In consideration of Ten (\$10.00) Dollars in hand paid by Assignee, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby assign, transfer and set over unto Assignee, all of Assignor's right, title, and interest in and to the Marks.

2. Assignor hereby sells, assigns, and transfers to Assignee, and Assignee hereby accepts the transfer of all of Assignor's right, title and interest in and to the (a) the Marks; (b) all the good will associated with and symbolized by the Marks and any intellectual property appurtenant thereto, inclusive of the related Domain Names referenced in Schedule 2 attached hereto; (c) any common law rights to the Marks; (d) all income, royalties, and payments hereafter due or payable, if any, to Assignor with respect to the Marks, and the right to sue and recover for the foregoing; and (e) all rights to sue and recover damages for past, present or future infringement of the foregoing commencing upon execution of this Assignment.

3. Each party will, without additional consideration, take such further actions and execute promptly such further documents as are necessary to effect and record the above Assignment, including any actions or documents required by the United States Patent and Trademark Office or other authority to document the assignment herein or as may be necessary to protect, secure and vest good, valid and marketable title to Assignee.

4. Assignor authorizes the United States Patent and Trademark Office to record the Marks as the property of Assignee and to issue certificates of registration to Assignee in Assignee's name.

5. This Assignment is subject to any and all licenses or other rights that may have been granted by Assignor or its predecessors in interest with respect to the Marks prior to the date hereof. Assignee, its successors and assigns, shall hold the rights to the Marks for and during the existence of the term and life of the Marks, as fully and as entirely as the same would have been held and enjoyed by Assignor had this Assignment not been made.

6. Each party warrants that (i) this Assignment is a legal, valid and binding obligation of the warranting party, (ii) it has full power and authority to enter into and perform its

obligations under this Assignment in accordance with its terms, and (iii) it is and will remain free of any obligations and restrictions that would prevent or impede its performance of its obligations under this Agreement. The Marks assigned herein are hereby assigned solely on an "as is" basis.


7. This Assignment is made without representation or warranty.


