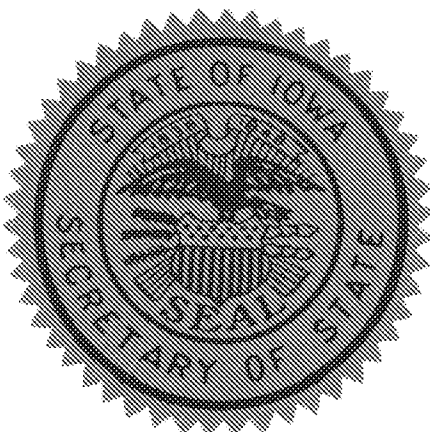

SECOND AMENDED AND RESTATED ARTICLES OF INCORPORATION  
OF  
2ND STORY SOFTWARE, INC.

TO THE SECRETARY OF STATE OF THE STATE OF IOWA:

Pursuant to sections 490.1003 and 490.1006 of the Iowa Business Corporation Act (the "Act"), the undersigned corporation (the "Corporation") adopts the following amendment to the Corporation's Second Amended and Restated Articles of Incorporation, as heretofore amended (the "Articles of Incorporation"):

1. The name of the Corporation is 2nd Story Software, Inc.
2. Article I of the Articles of Incorporation is hereby amended to read in its entirety as follows:

"I. NAME. The name of the Corporation is TaxACT, Inc."
