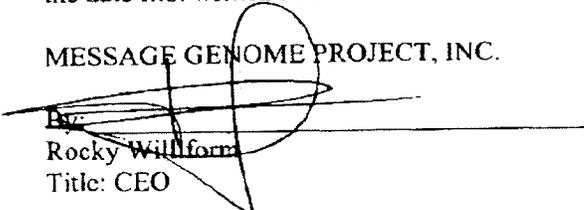
"FIRST. The name of the Corporation is "FIGNATURE, INC."
