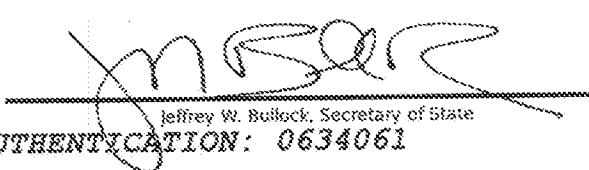

(Pursuant to Section 242 of the General Corporation Law of the State of Delaware)

Humbug, Inc. (the "Corporation"), a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware, does hereby certify as follows:

2.
